

As the October series concluded, it proved to be a challenging month for bulls, with Nifty erasing the gains of the past two months, falling over 7%—one of the steepest declines in recent times. This has dampened overall market sentiment.


The Nifty rollover stood at 65%, below the three-month average, and there was a decrease in outstanding contracts, signaling that significant long positions were unwound. Liquidity in the Indian equity market was further curtailed by strong hands, with net selling at ₹1,14,446 crore, the highest in some time. Interestingly, Domestic Institutional Investors mirrored this with net buying of ₹1,07,255 crore. However, Foreign Institutional Investors reduced their long positions, pushing the index futures Long-Short Ratio to 22%.

Given these factors, we believe the market is currently oversold. The 24,000-23,800 zone is likely to act as support in the near term, while a move above 24,200-24,300 could rekindle optimism

NIFTY & PCR Graph


